6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle I, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 9206 to read as follows:
9	CHAPTER 9206. DOUBLE PLATINUM RANCH WATER CONTROL AND IMPROVEMENT
10	DISTRICT NO. 1 OF GRAYSON COUNTY
11	SUBCHAPTER A. GENERAL PROVISIONS
12	Sec. 9206.001. DEFINITIONS. In this chapter:
13	(1) "Board" means the board of directors of the
14	district.
15	(2) "Director" means a member of the board.
16	(3) "District" means the Double Platinum Ranch Water
17	Control and Improvement District No. 1 of Grayson County.
18	Sec. 9206.002. NATURE OF DISTRICT. The district is a water
19	control and improvement district in Grayson County created under
20	and essential to accomplish the purposes of Section 59, Article
21	XVI, Texas Constitution.
22	Sec. 9206.003. CONFIRMATION ELECTION REQUIRED. If the
23	creation of the district is not confirmed at a confirmation
24	election held under Section 9206.064 before September 1, 2011:

AN ACT

1	(1) the district is dissolved September 1, 2011,
2	<pre>except that:</pre>
3	(A) any debts incurred shall be paid;
4	(B) any assets that remain after the payment of
5	debts shall be transferred to Grayson County; and
6	(C) the organization of the district shall be
7	maintained until all debts are paid and remaining assets are
8	transferred; and
9	(2) this chapter expires September 1, 2014.
10	Sec. 9206.004. INITIAL DISTRICT TERRITORY. (a) The
11	district is initially composed of the territory described by
12	Section 2 of the Act creating this chapter.
13	(b) The boundaries and field notes contained in Section 2 of
14	the Act creating this chapter form a closure. A mistake made in the
15	field notes or in copying the field notes in the legislative process
16	does not affect:
17	(1) the organization, existence, or validity of the
18	district;
19	(2) the right of the district to impose taxes;
20	(3) the validity of the district's bonds, notes, or
21	other indebtedness; or
22	(4) the legality or operation of the district or the
23	board.
24	Sec. 9206.005. ANNEXATION BY CITY OF GUNTER. (a)
25	Notwithstanding any other law, if all of the territory of the
26	district is annexed by the City of Gunter into the corporate limits
27	of that municipality before the date of the election held to confirm

- 1 the creation of the district, the district may not be dissolved and
- 2 shall continue until the district is dissolved under Section
- 3 43.074, Local Government Code.
- 4 (b) Any future annexation or inclusion of additional
- 5 territory into a district governed by this chapter may not occur
- 6 unless the City of Gunter is allowed to voluntarily annex the same
- 7 territory into its corporate limits.
- 8 [Sections 9206.006-9206.050 reserved for expansion]
- 9 SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 9206.051. DIRECTORS; TERMS. (a) The district is
- 11 governed by a board of five directors.
- 12 (b) Except as provided by Section 9206.061 of this code and
- 13 Section 49.102, Water Code, directors serve staggered four-year
- 14 terms, with the terms of two or three directors expiring June 1 of
- 15 <u>each even-numbered year.</u>
- Sec. 9206.052. ELECTION OF DIRECTORS. On the uniform
- 17 election date in May of each even-numbered year, the appropriate
- 18 number of directors shall be elected.
- [Sections 9206.053-9206.060 reserved for expansion]
- SUBCHAPTER B-1. TEMPORARY PROVISIONS
- Sec. 9206.061. INITIAL DIRECTORS. (a) On or after
- 22 September 1, 2007, a person who owns land in the district may submit
- 23 a petition to the Texas Commission on Environmental Quality
- 24 requesting that the commission appoint as initial directors the
- 25 <u>five persons named in the petition.</u>
- 26 (b) The commission shall appoint as initial directors the
- 27 <u>five persons named in the first petition received by the commission</u>

- 1 under Subsection (a).
- 2 (c) If an initial director fails to qualify for office, the
- 3 commission shall appoint a person to fill the vacancy.
- 4 (d) Initial directors serve until the earlier of:
- 5 (1) the date the first directors are elected at the
- 6 confirmation election under Section 9206.064; or
- 7 (2) the date this subchapter expires under Section
- 8 9206.066.
- 9 Sec. 9206.062. ORGANIZATIONAL MEETING OF INITIAL
- 10 DIRECTORS. As soon as practicable after all the initial directors
- 11 have qualified under Section 49.055, Water Code, the initial
- 12 directors shall meet at a location in the district agreeable to a
- 13 majority of the directors. At the meeting, the initial directors
- 14 shall elect officers from among the initial directors and conduct
- 15 any other district business.
- 16 Sec. 9206.063. CONSENT OF MUNICIPALITY REQUIRED. The
- 17 <u>initial</u> directors may not hold an election under Section 9206.064
- 18 until all of the territory of the district is included in the
- 19 corporate limits of the City of Gunter.
- 20 Sec. 9206.064. CONFIRMATION AND INITIAL DIRECTORS'
- 21 ELECTION. The initial directors shall hold an election to confirm
- 22 the creation of the district and to elect five directors as provided
- by Section 49.102, Water Code.
- Sec. 9206.065. INITIAL ELECTED DIRECTORS; TERMS. The
- 25 directors elected under Section 9206.064 shall draw lots to
- 26 determine which two shall serve until the first regularly scheduled
- 27 <u>election of directors and which three shall serve until the second</u>

- 1 regularly scheduled election of directors.
- Sec. 9206.066. EXPIRATION OF SUBCHAPTER. This subchapter
- 3 expires September 1, 2014.
- 4 [Sections 9206.067-9206.100 reserved for expansion]
- 5 SUBCHAPTER C. POWERS AND DUTIES
- 6 Sec. 9206.101. WATER CONTROL AND IMPROVEMENT DISTRICT
- 7 POWERS AND DUTIES. (a) The district has the powers and duties
- 8 provided by the general law of this state, including Chapters 49 and
- 9 51, Water Code, applicable to water control and improvement
- 10 districts created under Section 59, Article XVI, Texas
- 11 Constitution.
- (b) Notwithstanding Subsection (a), the district may not
- 13 act as a retail provider of water or wastewater services.
- (c) The district shall make its water and wastewater
- 15 facilities available to an entity holding the applicable
- 16 certificate of convenience and necessity.
- Sec. 9206.102. ROAD PROJECTS. (a) To the extent authorized
- 18 by Section 52, Article III, Texas Constitution, the district may
- 19 construct, acquire, improve, maintain, or operate macadamized,
- 20 graveled, or paved roads or turnpikes, or improvements in aid of
- 21 those roads or turnpikes, inside the district.
- 22 (b) A road project must meet or exceed all applicable
- 23 construction standards, zoning and subdivision requirements, and
- 24 regulatory ordinances of the municipality in whose corporate limits
- 25 or extraterritorial jurisdiction the district is located.
- 26 (c) If a portion of the territory of the district is
- 27 excluded from the corporate limits of the City of Gunter, the

1	district shall:
2	(1) improve, maintain, repair, and operate the roads
3	located in that portion of territory in accordance with the
4	ordinances and rules of the political subdivision possessing
5	jurisdiction over the roads in that portion of territory; and
6	(2) pay the entire cost of performing the district's
7	duties under Subdivision (1).
8	Sec. 9206.103. DIVISION OF DISTRICT. (a) The district may
9	be divided into two new districts only if:
10	(1) the district has no outstanding bonded debt;
11	(2) the district is not imposing ad valorem taxes; and
12	(3) each new district is within the corporate limits
13	of the City of Gunter.
14	(b) The division procedure is prescribed by Sections 53.030
15	through 53.041, Water Code. Sections 51.748 through 51.753, Water
16	Code, do not apply to the district.
17	(c) Any new district created by the division of the district
18	has all the powers and duties of the district.
19	(d) At the time of creation, any new district created by the
20	division of the district may not contain any land outside the area
21	described by Section 2 of the Act creating this chapter.
22	[Sections 9206.104-9206.150 reserved for expansion]
23	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
24	Sec. 9206.151. TAX TO REPAY BONDS. The district may impose
25	a tax to pay the principal of or interest on bonds or other
26	obligations issued under Section 9206.201.

SUBCHAPTER E. BONDS

- Sec. 9206.201. AUTHORITY TO ISSUE BONDS AND OTHER

 OBLIGATIONS. (a) The district may issue bonds or other obligations
 as provided by Chapters 49 and 51, Water Code, to finance the
 construction, maintenance, or operation of a project under Section
 9206.101 or 9206.102.
 - (b) The district may not issue bonds to finance projects authorized by Section 9206.102 unless the issuance is approved by a vote of a two-thirds majority of the district voters voting at an election called for that purpose.
- 11 (c) Bonds or other obligations issued or incurred to finance
 12 projects authorized by Section 9206.102 may not exceed one-fourth
 13 of the assessed value of the real property in the district.

- 10 SECTION 3. (a) The legal notice of the intention to
- 11 introduce this Act, setting forth the general substance of this
- 12 Act, has been published as provided by law, and the notice and a
- 13 copy of this Act have been furnished to all persons, agencies,
- 14 officials, or entities to which they are required to be furnished
- under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 16 Government Code.
- 17 (b) The governor, one of the required recipients, has
- 18 submitted the notice and Act to the Texas Commission on
- 19 Environmental Quality.
- 20 (c) The Texas Commission on Environmental Quality has filed
- 21 its recommendations relating to this Act with the governor, the
- 22 lieutenant governor, and the speaker of the house of
- 23 representatives within the required time.
- 24 (d) All requirements of the constitution and laws of this
- 25 state and the rules and procedures of the legislature with respect
- 26 to the notice, introduction, and passage of this Act are fulfilled
- 27 and accomplished.

1 SECTION 4. This Act takes effect September 1, 2007.
