5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8254 to read as follows:
8	CHAPTER 8254. PRESTON SUMMIT MUNICIPAL UTILITY DISTRICT NO. 1 OF
9	GRAYSON COUNTY .
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8254.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Director" means a board member.
14	(3) "District" means the Preston Summit Municipal
15	Utility District No. 1 of Grayson County.
16	Sec. 8254.002. NATURE OF DISTRICT. The district is a
17	municipal utility district in Grayson County created under and
18	essential to accomplish the purposes of Section 52, Article III,
19	and Section 59, Article XVI, Texas Constitution.
20	Sec. 8254.003. CONFIRMATION ELECTION REQUIRED. If the
21	creation of the district is not confirmed at a confirmation
22	election held under Section 8254.023 before September 1, 2011:
23	(1) the district is dissolved September 1, 2011,
24	except that the district shall:

AN ACT

1	(A) pay any debts incurred;
2	(B) transfer to Grayson County any assets that
3	remain after the payment of debts; and
4	(C) maintain the organization of the district
5	until all debts are paid and remaining assets are transferred; and
6	(2) this chapter expires September 1, 2014.
7	Sec. 8254.004. INITIAL DISTRICT TERRITORY. (a) The
8	district is initially composed of the territory described by
9	Section 2 of the Act creating this chapter.
10	(b) The boundaries and field notes contained in Section 2 of
11	the Act creating this chapter form a closure. A mistake made in the
12	field notes or in copying the field notes in the legislative process
13	does not affect:
14	(1) the organization, existence, or validity of the
15	<pre>district;</pre>
16	(2) the right of the district to impose taxes;
17	(3) the validity of the district's bonds, notes, or
18	indebtedness; or
19	(4) the legality or operation of the district or the
20	board.

22	SUBCHAPTER A-1. TEMPORARY PROVISIONS
23	Sec. 8254.021. TEMPORARY DIRECTORS. (a) On or after
24	September 1, 2007, a person who owns land in the district may submit
25	a petition to the Texas Commission on Environmental Quality
26	requesting that the commission appoint as temporary directors the
27	five persons named in the petition.

- 1 (b) The commission shall appoint as temporary directors the
- 2 five persons named in the first petition received by the commission
- 3 under Subsection (a).
- 4 (c) If a temporary director fails to qualify for office, the
- 5 commission shall appoint a person to fill the vacancy.
- 6 (d) Temporary directors serve until the earlier of:
- 7 (1) the date directors are elected under Section
- 8 8254.023; or
- 9 (2) the date this chapter expires under Section
- 10 8254.003.
- 11 Sec. 8254.022. ORGANIZATIONAL MEETING OF TEMPORARY
- 12 DIRECTORS. As soon as practicable after all the temporary
- 13 directors have qualified under Section 49.055, Water Code, the
- 14 temporary directors shall meet at a location in the district
- 15 agreeable to a majority of the directors. At the meeting, the
- 16 temporary directors shall elect officers from among the temporary
- 17 directors and conduct any other district business.
- 18 Sec. 8254.023. CONFIRMATION AND INITIAL DIRECTORS'
- 19 ELECTION; ANNEXATION BY CITY. (a) The temporary directors shall
- 20 hold an election to confirm the creation of the district and to
- 21 elect five directors as provided by Section 49.102, Water Code.
- 22 (b) The temporary directors may not hold the election until
- 23 the City of Gunter has annexed into its corporate limits all
- territory described by Section 2 of the Act creating this chapter.
- 25 Sec. 8254.024. INITIAL ELECTED DIRECTORS; TERMS. The
- 26 directors elected under Section 8254.023 shall draw lots to
- 27 determine which two shall serve until the first regularly scheduled

election of directors and which three shall serve until the second 1 2 regularly scheduled election of directors. 3 Sec. 8254.025. EXPIRATION OF SUBCHAPTER. This subchapter 4 expires September 1, 2014. [Sections 8254.026-8254.050 reserved for expansion] 5 6 SUBCHAPTER B. BOARD OF DIRECTORS 7 Sec. 8254.051. GOVERNING BODY; TERMS. (a) The district is 8 governed by a board of five directors. 9 (b) Directors serve staggered four-year terms. 10 [Sections 8254.052-8254.100 reserved for expansion] 11 SUBCHAPTER C. POWERS AND DUTIES Sec. 8254.101. MUNICIPAL UTILITY DISTRICT POWERS AND 12 13 DUTIES. The district has the powers and duties provided by the general law of this state, including Chapters 49 and 54, Water Code, 14 15 applicable to municipal utility districts created under Section 59, 16 Article XVI, Texas Constitution. 17 Sec. 8254.102. WATER AND WASTEWATER FACILITIES AND SERVICES. (a) The district shall make available any district water 18 or wastewater facility to each person that holds a certificate of 19 20 convenience and necessity for land in the district. 21 (b) The district may not provide retail water or wastewater 22 services. Sec. 8254.103. ROAD PROJECTS. (a) To the extent authorized 23 by Section 52, Article III, Texas Constitution, the district may 24 25 construct, acquire, improve, maintain, or operate macadamized, 26 graveled, or paved roads or turnpikes, or improvements in aid of

those roads or turnpikes, inside the district.

1	(b) A road project must meet all applicable construction
2	standards, zoning and subdivision requirements, and regulations of
3	each municipality in whose corporate limits or extraterritorial
4	jurisdiction the district is located.
5	Sec. 8254.104. MAINTENANCE AND REPAIR OF ROADS IN TERRITORY
6	EXCLUDED FROM CITY. If the City of Gunter excludes district
7	territory from the city's corporate limits, the district shall
8	maintain, improve, operate, and repair any road located in that
9	territory in accordance with the ordinances and rules of each
10	political subdivision in whose jurisdiction the road is located.
11	Sec. 8254.105. DIVISION OF DISTRICT. (a) The district may
12	be divided into two new districts only if the district:
13	(1) has no outstanding bonded debt; and
14	(2) is not imposing ad valorem taxes.
15	(b) The division procedure is prescribed by Sections 53.030
16	through 53.041, Water Code.
17	(c) Any new district created by the division of the district
18	has all the powers and duties of the district.
19	(d) Any new district created by the division of the district
20	may not, at the time the new district is created, contain any land:
21	(1) outside the area described by Section 2 of the Act
22	<pre>creating this chapter; or</pre>
23	(2) outside the corporate limits of the city of
24	Gunter.

26	RESOLUTIONS. The district shall comply with all applicable
27	requirements of any ordinance or resolution adopted by the

- 4 may not add land to the district under Subchapter J, Chapter 49,

- 7 (b) Section 43.075, Local Government Code, does not apply to
- 8 the district.

- Sec. 8254.151. TAX TO REPAY BONDS. The district may impose
- 12 a tax to pay the principal of or interest on bonds or other

- 14 [Sections 8254.152-8254.200 reserved for expansion]
- SUBCHAPTER E. BONDS
- Sec. 8254.201. AUTHORITY TO ISSUE BONDS AND OTHER
- OBLIGATIONS. (a) The district may issue bonds or other obligations
- 18 as provided by Chapters 49 and 54, Water Code, to finance the
- 19 construction, maintenance, or operation of a project under Section
- 20 8254.101 or 8254.103.
- 21 (b) The district may not issue bonds or other obligations to
- finance projects authorized by Section 8254.103 unless the issuance
- 23 <u>is approved by a vote of a two-thirds majority of the district</u>
- voters voting at an election held for that purpose.
- 25 (c) Bonds or other obligations issued or incurred to finance
- 26 projects authorized by Section 8254.103 may not exceed one-fourth
- of the assessed value of the real property in the district.
