Dallas Public Library June, 1985 JUNE PERMITS

In June the State Securities Board issued permits for 289 issuers to sell \$3,453,594,614 in securities, as compared to \$2,810,175,023 for the month of May. \$2,490,261,312 of the June permits represent Money Market Funds.

Total dollar amount of securities applications processed for the first ten months of this fiscal year was \$27,448,943,025, as compared with \$28,559,778,601 for the same period \$18,318,279,427 of the \$27 Billion Plus figure represents Money Market Funds, as compared to \$18,999,453,593 for the same period last year. Total number of applications processed for the first ten months of this fiscal year was 3,149 as compared to 3,351 for the same period last year.

## INDICTMENT

On June 26, 1985, Lawrence F. Long of Dallas, Texas, President of Onyx Oil & Gas, Inc., was indicted by a Dallas County Grand Jury for violations of the Texas Securities Act in connection with the sale of an interest in an oil and gas drilling program known as the Sherry-Hannah #2 Drilling Venture. The indictment alleges that Long committed fraud by failing to disclose to present investors that funds contributed by past investors for two previous drilling ventures offered by Onyx had been used for purposes other than those for which the funds were invested; that the funds invested in the Onyx drilling programs were not maintained in special accounts as represented to investors; and that the funds of earlier investors in the Sherry-Hannah #2 Drilling Venture had been spent for other purposes.

#### INJUNCTIONS

On June 21, 1985, Judge Harley Clark in Austin, Travis County, Texas, issued a Temporary Restraining Order against Central Mortgage and Trust, Inc., MortgageBanc & Trust, Inc., John E. Signorelli, and others all of Conroe, Texas. The Order enjoined Defendants from selling "Investment Trust Deposits" ("ITD's") in which investors' funds were pooled and invested in various ventures by Defendants, mostly real estate notes, in violation of the registration requirements of the Texas Securities Act. Defendants were further enjoined from committing fraud in connection with the sale of securities. The Order was issued

the day the State filed its Petition, in which it alleged that Defendants committed fraud by, among other things, misrepresenting that the mortgage-backed ITD's were fully insured and guaranteed by the full faith and credit of the U.S. Government. The Court further enjoined Defendants from disposing of the assets of the companies involved.

On June 28, the Banking Commissioner of Texas placed Central Mortgage and Trust, Inc. in liquidation for the protection of investors. The Banking Commissioner's order was based on findings by his examiners that the company's liabilities far exceeded its assets.

On June 28, 1985, the Commissioner issued a Cease Publication Notice regarding Investors MortgageBanc and Trust Corporation, Inc. directed to J. W. Fuller and Carl Bridges of Conroe, Texas to Cease Publication of advertisements in the <u>Wall Street Journal</u> and local newspapers. The Notice was based on a finding that the advertisements are misleading in that Investors MortgageBanc and Trust states that the investments, promising up to 14.76% annual interest, are guaranteed and secured without disclosing how or by whom the securities are guaranteed and secured.

## RESCISSION OFFER

As part of the proceeding In the Matter of Dr. Raj Gopal, Indus Technologies, Inc., and Indus Electronics Fund, in which a Cease and Desist Order was entered by the Securities Commissioner on May 21, 1985, Dr. Raj Gopal and Indus Technologies, Inc. notified the State Securities Board on June 14, 1985 that they had made a rescission offer to 14 Texas investors for a total of \$55,000.
