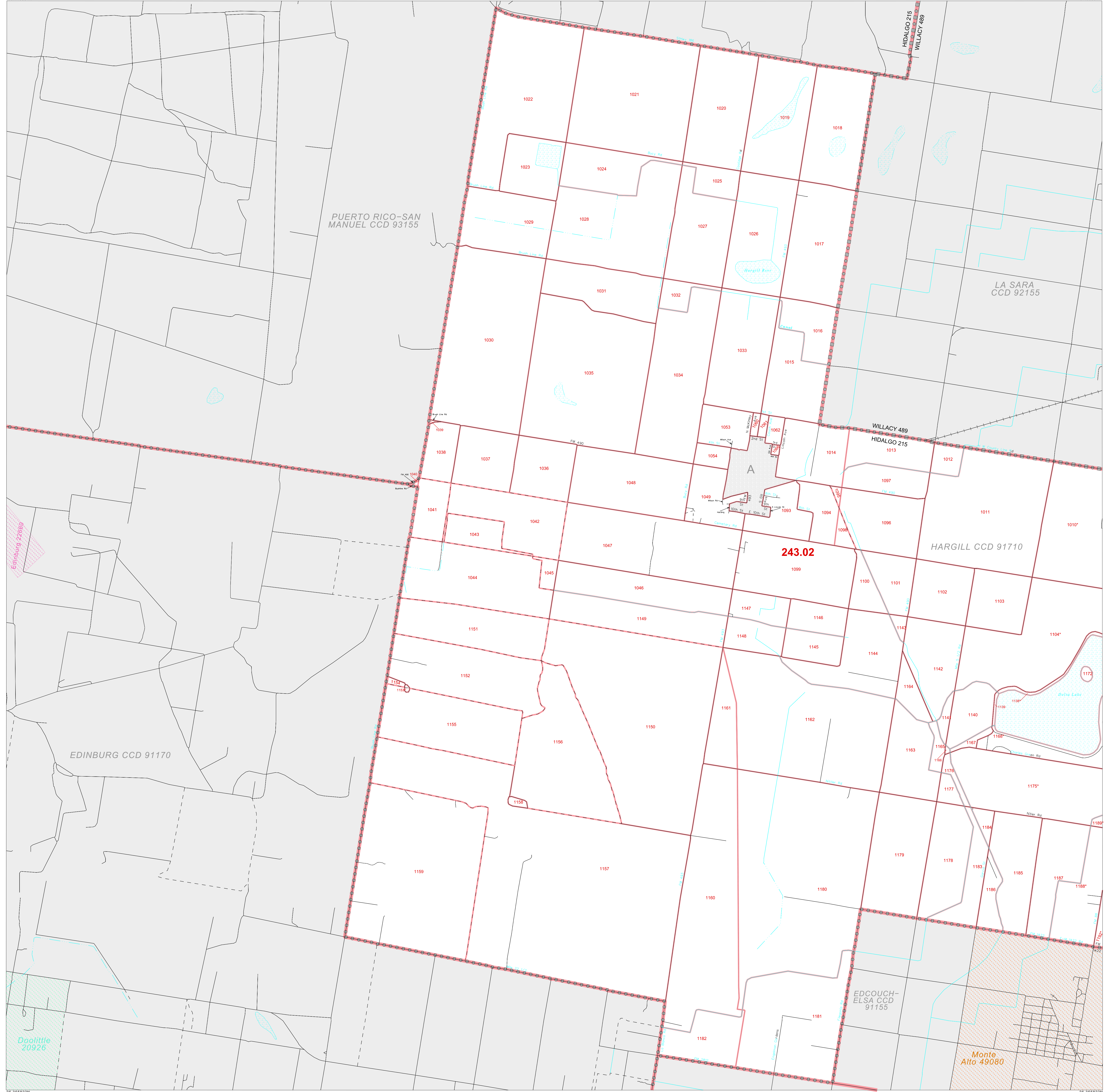


CENSUS 2000 BLOCK MAP: HARGILL CCD

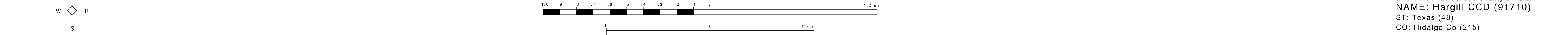
