5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. This Act shall be known as Kari's Law.
7	SECTION 2. Subtitle B, Title 9, Health and Safety Code, is
8	amended by adding Chapter 771A to read as follows:
9	CHAPTER 771A. ACCESS TO EMERGENCY COMMUNICATIONS SERVICES IN
10	GENERAL
11	Sec. 771A.001. DIRECT ACCESS TO 9-1-1 SERVICE REQUIRED.
12	(a) In this chapter:
13	(1) "9-1-1 service" means a communications service
14	that connects users to a public safety answering point through a
15	9-1-1 system.
16	(2) "Business service user" means a user of business
17	service that provides telecommunications service, including 9-1-1
18	service, to end users through a publicly or privately owned or
19	controlled telephone switch.
20	(3) "Commission" means the Commission on State
21	Emergency Communications.
22	(4) "Emergency communication district" means:
23	(A) a public agency or group of public agencies
24	acting jointly that provided 9-1-1 service before September 1,

- 1 1987, or that had voted or contracted before that date to provide
- 2 that service; or
- 3 (B) a district created under Subchapter B, C, D,
- 4 F, or G, Chapter 772.
- 5 (5) "Internet Protocol enabled service" has the
- 6 meaning assigned by Section 51.002, Utilities Code.
- 7 (6) "Telephone system" includes a multiline telephone
- 8 system.
- 9 (b) This section applies to the extent the section is not
- 10 <u>inconsistent with or preempted by federal law.</u>
- (c) Notwithstanding any other law, a business service user
- 12 that owns or controls a telephone system or an equivalent system
- 13 that uses Internet Protocol enabled service and provides outbound
- 14 dialing capacity or access shall configure the telephone system or
- 15 equivalent system to allow a person initiating a 9-1-1 call on the
- 16 system to directly access 9-1-1 service by dialing the digits 9-1-1
- 17 without an additional code, digit, prefix, postfix, or trunk-access
- 18 code.
- 19 (d) A business service user that provides residential or
- 20 business facilities, owns or controls a telephone system or an
- 21 equivalent system that uses Internet Protocol enabled service, and
- 22 provides outbound dialing capacity or access shall configure the
- 23 <u>telephone system or equivalent system to provide a notification to</u>
- 24 <u>a central location on the site of the residential or business</u>
- 25 facility when a person within the residential or business facility
- 26 dials 9-1-1 if the system is able to be configured to provide the
- 27 notification without an improvement to the system's hardware. This

- 1 subsection does not require a business service user to have a person
- 2 available at the central location to receive a notification.
- 3 (e) The commission or the applicable emergency
- 4 communication district shall grant a one-year waiver of the
- 5 requirements under this section to a business service user if:
- 6 (1) the requirements would be unduly and unreasonably
- 7 cost prohibitive for a business service user to comply with; and
- 8 (2) the business service user provides an affidavit
- 9 not later than September 1 of each year stating:
- 10 (A) the manufacturer and model number of the
- 11 telephone system or equivalent system that needs to be reprogrammed
- 12 or replaced;
- 13 (B) that the business service user made a good
- 14 faith attempt to reprogram or replace the system; and
- (C) if the telephone system or equivalent system
- 16 does not comply with Subsection (c), that the business service user
- 17 agrees to place an instructional sticker immediately adjacent to
- 18 each telephone that is accessed using the noncompliant system
- 19 indicating that during the waiver period the telephone is unable to
- 20 directly dial 9-1-1 and providing instructions for accessing 9-1-1
- 21 in case of an emergency. The instructional sticker must be printed
- 22 in at least 16-point boldface type in a contrasting color using a
- 23 font that is easily readable.
- 24 (f) The commission may adopt rules to implement this section
- 25 for areas that are governed by a regional plan, and an emergency
- 26 communication district may adopt those rules in accordance with
- 27 Section 771.062.

- 1 (g) On the request of the business service user, the
- 2 commission, an emergency communication district, or a home-rule
- 3 municipality that independently operates a 9-1-1 system shall
- 4 provide assistance to a business service user that is within the
- 5 applicable governmental entity's jurisdiction in complying with
- 6 this section.
- 7 SECTION 3. A business service user, as defined by Section
- 8 771A.001(a), Health and Safety Code, as added by this Act, shall
- 9 comply with Section 771A.001, Health and Safety Code, as added by
- 10 this Act, not later than September 1, 2016.
- 11 SECTION 4. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2015.
